INSTRUCTIONS

1. All rigging must conform with Show Management rules, regulations and facility limitations.
2. The Northwest Georgia Trade Center is the exclusive provider of rigging services, truss and chain motors. The Trade Center will hang all lighting, truss, chain motors, signs, etc.
3. All overhead rigging and flown objects must be assembled and disassembled by the Trade Center. Exhibitors and/or display company may supervise only, but will not be allowed to assemble/disassemble or install and remove rigging or flown objects. No one other than Trade Center employees will be permitted in lifts without signing the Trade Center liability waiver with prior approval of Management. Please complete the Labor Order Form for labor to assemble/disassemble rigging and flown objects.
4. Rigging plots must be submitted in advance by exhibitor. These plots must show the location of the hang points, and the weight of each point. The plot must show the Booth outline with the Front Aisle for reference.
5. Any special equipment required will be billed at prevailing rates. Prices are for the entire show. No drayage or freight charges will be applied.
6. Exhibitors may bring in or rent lighting from outside companies.
7. **ELECTRICAL SERVICE** requirements for hoists must be ordered in advance on the **ELECTRICAL SERVICE** order form.
8. For boom lift and overhead rigging crew, use the **"Hanging Signs"** order form.
